Assignor agrees for itself and its heirs, legal representatives and assigns, without further compensation, upon request to perform such lawful acts, to promptly provide Assignee with all pertinent facts and documents relating to said invention or application as may be known and accessible, to testify in any interference or litigation related to said invention or application and to sign such further applications, assignments, preliminary statements and other lawful documents as the Assignee may reasonably request to effectuate fully this Assignment.

This Assignment may be executed on separate counterparts, each of which is deemed to be an original and all of which when taken together constitute one and the same agreement. Any telecopied signature shall be deemed a manually executed and delivered original.

This Assignment shall inure to the benefit of and be enforceable by the Assignee and its successors and assigns and shall be binding upon and enforceable against the Assignor and each of its respective successors and assigns and heirs agents and personal representatives.
