- the right to file counterparts to the Application in all countries and regions;
- the right to claim priority from the Application in all countries and regions;
- all patents or design registrations which may be granted on or as a result thereof; and
- any reissue or reissues of such patents or design registrations;

the same to be held and enjoyed by the Assignee, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which such patents respectively may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by the Assignor, had this Assignment, sale and transfer not been made.

The Assignor hereby covenants that they: have full right to convey the entire interest herein assigned; and have not executed and will not execute any agreement to transfer any rights in the Inventions and/or the Application to anyone other than the Assignee or that is otherwise in conflict herewith.

The Assignor promises that they shall:



- each time a request is made and without undue delay, execute and deliver all such papers as may be necessary or desirable to perfect the title to the Inventions, the Application, and the patents or design registrations in the Assignee, its successors, assigns, nominees or legal representatives;
- communicate to the Assignee, or its nominees, all known facts respecting the Inventions, the Application and said patents or design registrations;
- testify in any legal proceedings;
- sign all lawful papers;
- execute all disclaimers and divisional, continuing, reissue and foreign applications;
- make all rightful oaths; and

generally do everything possible to aid the Assignee, its successors, assigns, nominees and legal representatives to obtain and enforce for its or their own benefit, proper patent protection for the Inventions in all countries;
all at the expense, however, of the Assignee or its successors, assigns, nominees or legal representatives.

The Assignor hereby irrevocably designates and appoints the Assignee and its duly authorized officers and agents, and their successors, as their agents and attorneys-in-fact, to act on the Assignors' behalf and instead of the Assignor, to execute and file applications to patent or register the Inventions in all countries, and to do all other proper lawfully-permitted acts to further the assignment, prosecution and issuance of patents or design registrations for the Inventions with the same legal force and effect as if executed by the Assignor. This power of attorney shall be deemed coupled with an interest and is irrevocable.

The Assignor hereby authorizes and requests any official of any country or countries whose duty it is to issue patents or design registrations on applications to issue to the Assignee, its successors, assigns, nominees or legal representatives all patents or design registrations for the Inventions in accordance with the terms of this Assignment.

The Assignor authorizes the firm of Borden Ladner Gervais LLP to correct errors in this assignment or to insert any further identification necessary to make this assignment suitable for recordation in the Patent Offices of any country as may be required.
