and Design Applications, and rights to the entire term of any Patents, Certificates and/or Registrations that may be granted upon any of the foregoing applications, and any priority rights (i.e., the right to claim the benefit of priority) to any of the foregoing Applications and/or Patents in whole or part, and Inventor's Certificates, and any and all other like rights of exclusion. Assignor authorizes Assignee to apply in all countries in its name or in Assignor's name for any such rights as have been named in the foregoing section.

Assignor authorizes the rights, titles, and interests to be held and enjoyed by the Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor hereby covenants that he has full right to convey the entire interest herein assigned and that no agreement has been executed or will be executed in conflict herewith.
