**TERMINATION AND RELEASE
OF
GRANT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS**

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS, dated effective as of August 7, 2013, by and between COLE TAYLOR BANK, an Illinois banking corporation, with an office at 9950 W. Higgins Road, Rosemont, Illinois 60018 (the "Lender"), under the Grant of Security Interest in Trademarks and Patents (as defined herein) and PARMELEE INDUSTRIES, INC., a Delaware corporation, with an office at 8101 Lenexa Drive, Lenexa, Kansas 66285 (the "Company").

WHEREAS, pursuant to the terms of (i) the Credit and Security Agreement dated as of September 30, 2010 between the Company, the Susan Parmelee Trust and the Lender (as amended from time to time, the "Loan Agreement"), and (ii) the Grant of Security Interest in Trademark and Patents dated as of September 30, 2010, between the Lender and the Company recorded with the United States Patent and Trademark Office on March 17, 2011 at Patent Reel 025972 and Frame 0182, the Company granted to the Lender a security interest in and lien on, and collaterally assigned to the Lender the patents identified on Schedule A attached hereto (such patents being referred to herein as the "Named Patents"); and

WHEREAS, the Lender has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Patents as herein provided;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender and the Company hereby agree as follows:

1. Release and Assignment. The Lender hereby terminates and releases its security interest in and first priority lien on all of the Company's Named Patents, and the Lender hereby assigns and transfers to the Company, without recourse, all of the Lender's right, title and interest in and to each of the Named Patents, effective as of the date set forth above.
2. Acknowledgment and Acceptance. The Company hereby acknowledges and accepts the foregoing release and assignment by the Lender.
3. Counterparts. This release may be executed in any number of counterparts which shall together constitute one and the same agreement.
