We agree that, when requested, we will, without charge to said **ASSIGNEE**, but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in all countries and for vesting title thereto in said **ASSIGNEE**, its successors, assigns and legal representatives or nominees.


