


the name of **Cooper Technologies Company** or its designee insofar as permitted by applicable law;

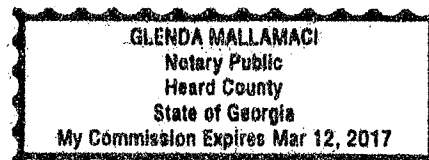



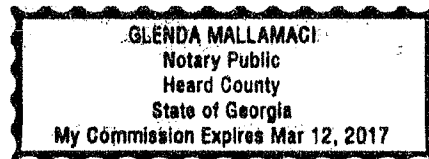
