

DETAILS OF THE DEED

Date of the deed

This deed is made on the 25% of July , 2011.

AND

RECITALS

- A The Assignor has applied for certain patent applications (the Patents) in various countries.
- B The Assignor has agreed to assign to the Assignee all its rights, title and interests in and to the Patents, Inventions and Know-How, including the right to apply for or obtain corresponding rights for such Patents, Inventions and Know-how in any country.

The parties agree as follows:

1 INTERPRETATION

In this deed the following definitions apply:

Know-how means all technical information, specifications, techniques, formulae, methods, processes, know-how, instructions, experience and expertise, manuals, plans, data, designs, drawings, diagrams, algorithms, software, documents, materials and/or information, in whatever form or medium, containing, describing or relating to the Inventions and Patents, including without any limitation the documents listed in Schedule 2.

Patents mean the patents and patent applications set out in Schedule 1.

2 ASSIGNMENT AND CONSIDERATION

- Subject to Clause 2.2, the Assignor hereby assigns to the Assignee as of the date of this deed:
 - (a) the benefit of the Patents, Inventions and Know-How and all rights, title and interests arising from them;
 - (b) all corresponding rights obtainable in any country in respect of the Patents, Inventions and Know-How; and
 - (c) all rights, powers, liberties, and associated immunities.
- In consideration for the rights under this Agreement (including the rights assigned under Clause 2.1 and the transfer of Know-How under Clause 3), Assignee will pay Assignor the sum of AUD. (GST exclusive) to be paid upon signing of this deed.

3 TRANSFER OF KNOW-HOW

Assignor shall forthwith, and no later than 60 days of the date of this deed, deliver, divulge, transfer, disclose, impart or otherwise communicate to Assignee all now-How in whatever form or medium in its possession, and all copies thereof. In addition, the Assignor and its directors will be available for consultation on the Patents and Know-how as and when required by Assignee, without additional costs to the Assignee. Any breach of this Clause 3 shall constitute a material breach of this deed, and shall entitle Assignee to terminate this deed and recover all sums and amounts paid to Assignee under or in connection with Clause 2.2 of this Agreement.

4 FURTHER ACTION

The Assignor must at their expense do all acts and execute all documents necessary to transfer to the Assignee title to the Patents, Inventions and Know-How. In the event of default the Assignor appoints the Assignee as the Assignor's attorney for such purpose.

5 COSTS

All fees, costs and expenses incurred by the Assignor in connection with enabling the Assignee to be registered as the sole owner of the Patents are to be borne and paid by the Assignor.

6 GST

- 6.1 In this section, all terms have the meaning given to them by the:
 - (a) A New Tax System (Goods and Services Tax) Act 1999 (Cth); and
 - (b) A New Tax System (Goods and Services Tax) Regulations 1999 (Cth); as amended from time to time and all material published by the Australian Taxation Office (ATO).
- The parties agree that all amounts payable under this deed are exclusive of GST.
- In any Taxable Supply under this deed, if applicable, the Assignee must, subject to the Assignor providing the Recipient with a Tax Invoice, pay to the Assignor an additional amount on account of the GST payable in respect of the Taxable Supply within fourteen (14) days of receiving that Tax Invoice.
- If the amount of GST liability of the Assignor under this deed differs from the amount of GST paid by the Assignor, because of the occurrence of an Adjustment Event, then the Assignor must issue an Adjustment Note to the Assignee within seven (7) days of the Adjustment Event. The amount of GST paid by the Assignee will be adjusted accordingly by a further payment by the Assignee to the Assignor, or by the Assignor to the Assignee, as the case requires, within seven (7) days of the Assignor issuing that Adjustment Note to the Assignee.
- If any penalty, interest, or additional tax (Extra Liability) is imposed in relation to the GST payable under this lease by a party (Paying Party) as a result of the other party's default (Defaulting Party) under this deed, the Defaulting Party must pay to the Paying Party the amount of any such Extra Liability within fourteen (14) days after the Paying Party provides the Defaulting Party with proof of the Extra Liability. A notice from the ATO will be sufficient proof of the Extra Liability.

 - (d) the Assignor was entitled to make all patent applications which it has made and none of the Inventions, to the best knowledge of the Assignor, were at the time part of the prior art in the field or fields to which they relate;
 - (e) all such patent applications have been made in the prescribed form and the prescribed manner;
 - (f) the Assignee will have and enjoy quiet possession of the Patents, Inventions and Know-How, uninterrupted by the Assignor or any person claiming under the Assignor;
