**PATENT ASSIGNMENT**

WHEREAS, TELEFONAKTIEBOLAGET L M ERICSSON, a Swedish public limited liability company with reg. no. 556015-0680, and having a place of business at Torshamnsgatan 23, 164 83 Stockholm, Sweden, (hereafter called "L M ERICSSON") was the owner of all right, title, and interest in and to the Patent Numbers listed in Appendix A (hereinafter collectively referred to as "PATENT RIGHTS");

WHEREAS, LM ERICSSON has assigned the PATENT RIGHTS to its subsidiary ERICSSON AB, a Swedish limited liability company with reg. no. 556056-6258, and having a place of business at Torshamnsgatan 23, 164 83 Stockholm, Sweden, (hereafter called "ASSIGNOR"), which assignment is hereby confirmed by L M Ericsson;

WHEREAS, CELECA AB, a Swedish limited liability company, with reg. no. 556838-7004, and having a registered address at Torshamnsgatan 23, 164 83 Stockholm, Sweden, (hereinafter called "ASSIGNEE"), is desirous of acquiring the entire right, title, and interest in and to said PATENT RIGHTS;

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt of which is hereby acknowledged,

- (a) L M ERICSSON has sold, assigned and transferred effective as of an assignment date of 1 July 2013, and otherwise does hereby sell, assign and transfer to the ASSIGNEE, L M ERICSSON's entire right, title, and interest in and to said PATENT RIGHTS as of 1 July 2013; and
- (b) the said ASSIGNOR has sold, assigned, and transferred effective as of an assignment date of 1 July 2013, and does hereby sell, assign, and transfer to the ASSIGNEE, ASSIGNOR's entire right, title, and interest in and to said PATENT RIGHTS as of 1 July 2013 (subject to licenses and similar rights granted to ASSIGNOR and ASSIGNOR's affiliates, or to any third parties under agreements of ASSIGNOR or ASSIGNOR'S affiliates that were effective up to and including 1 July 2013), the same to be held and enjoyed by the ASSIGNEE for its own use and benefit and for the use and benefit of its licensees, successors, assigns or other legal representatives; with the right to sue for infringement and damages and collect the same for its own use and benefit and for the use and benefit of its licensees, successors, assigns, or other legal representatives and further in accordance with the terms of the Patent Assignment Agreement effective as of 1 July 2013, which agreement will prevail over this Assignment to the extent of any inconsistency;
