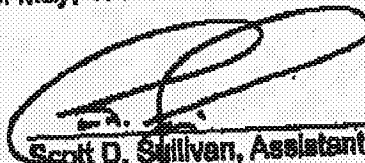
1. The name of the corporation is MCI Telecommunications Corporation.
