AND STAR CO hereby covenants that it has full right to convey the entire interest herein assigned and that no assignment, sale, agreement or encumbrance has been as of the Signing Date or will be made or entered by STAR CO between the Signing Date and the Closing Date, as defined in the Patent Purchase Agreement, that would conflict with this assignment.

STAR CO hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and any official of any country or countries foreign to the United States of America whose duty it is to issue patents on applications as aforesaid, to issue to the Assignee, as assignee of the right, title and interest set forth above, any and all Letters Patent for said inventions or improvements, which may be issued and granted on or as a result of any application aforesaid, in accordance with the terms of this Assignment.
