**NOTICE OF RELEASE OF BUSINESS MORTGAGE AND SHARE PLEDGES**

From: Hercules Technology Growth Capital Inc. (the **Pledgee**)

To: Hormos Medical Oy (1085385-9) (the **Company**)

Dear Sirs,

We refer to (i) any notice given to you regarding the shares in the Company (the **Shares**) pledged in favour of the Pledgee under the share pledge agreement securing the loan and security agreement, dated 26 January 2006, between the Pledgee as lender and QuatRx Pharmaceuticals Company as borrower, and (ii) the security agreement relating to a business mortgage note of EUR 25,000,000 with a priority date of 5 June 2009 (the **Mortgage Note**) and certain IP rights (as listed in Appendix 1) (the **IP Rights**) between the Company and the Pledgee securing the loan and security agreement, dated 26 January 2006.

We confirm that we have released (i) the Mortgage Note, (ii) the pledge of IP Rights, (iii) the pledge of the Shares, and (iv) all of our rights in relation to the agreement referred to above and we confirm that:

- (i) the board of directors of the Company may remove the note regarding the pledge of the shares in the Company by QuatRx Pharmaceuticals Company in favour of the Pledgee from the Company's share and shareholder register;
- (ii) the Company or any new pledgee may apply for the removal of the registration entry in the Finnish business mortgage register in respect of the rights of the Pledgee to the Mortgage Note; and
- (iii) the Company or any new pledgee may apply for the removal of the registration entries in the relevant registers in respect of the rights of the Pledgee to the IP Rights.
