

AGREEMENT

THIS AGREEMENT is made and entered into by and among SOROS SURGICAL SYSTEMS, INC., an Indiana corporation ("Suros"), KOHALA, INC., f/k/a Promex, Inc., an Indiana corporation ("Promex"), PROMEX TECHNOLOGIES, LLC, f/k/a Promex/US Biopsy, LLC, an Indiana limited liability company, HSVIT, LLC, f/k/a Promex, LLC, an Indiana limited liability company, JOSEPH L. "Pop Gun" Technology. The parties acknowledge that Mark has created an invention consisting of a single or double action spring loaded biopsy device with non-fully automated vacuum assist features. Such device was the subject of certain invention disclosures filed by Mark with Promex, including, without limitation, those disclosures made on June 30, 2003, September 11, 2003, September 19, 2003 and September 26, 2003, which disclosures will be provided to Suros upon execution of this Agreement. The foregoing described technology is hereinafter referred to as the "Pop Gun Technology"; provided, however, that the "Pop Gun Technology" does not mean other non-fully automated, vacuum assisted tissue removal technology that Promex has developed or develops in the future and which is not invented by Mark or Miller. Mark, Miller and the Promex Companies jointly and severally represent and warrant to Suros that Promex has filed a provisional patent application with respect to the Pop Gun Technology, which is the only application it has filed with respect to the Pop Gun Technology. Promex hereby assigns such application to Suros without any additional consideration and grants power of attorney to Suros to further prosecute such application. Further, Promex agrees that it will use its best efforts to locate and provide to Suros any other invention disclosures it may have related to the Pop Gun Technology.

Although Suros believes that it has already acquired the rights to the Pop Gun Technology, for the avoidance of doubt, Promex, Mark and Miller hereby assign to Suros any and all right, title and interest which they may have had in and to the Pop Gun Technology without the payment of any additional consideration. Suros agrees that it will prosecute and maintain any and all patents pertaining to the Pop Gun Technology, and agrees to abide by the provisions of Section 1(a-c) above with respect to the Pop Gun Technology. Suros will retain the right to control and decide any matters as to the preparation, filing and prosecution of
