

CERTIFICATE OF INCORPORATION

STRAVELIS, INC.**

Stravelis, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

FIRST: That through a unanimous written consent of the Board of Directors of Stravelis, Inc. resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling for a meeting or written consent of the stockholders of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of this corporation be amended by changing the Article thereof numbered "I" so that, as amended, said Article I shall hereafter be and read as follows:

"ARTICLE I.

The name of this corporation is Tempo Semiconductor, Inc."

SECOND: That thereafter, pursuant to resolution of its Board of Directors, the stockholders of said corporation executed a written consent in lieu of a meeting of stockholders in accordance with Section 228 of the General Corporation Law of the State of Delaware, which written consent in favor of the amendment was signed by holders of outstanding stock having not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting at which all shares entitled to vote thereon were present and voted.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
