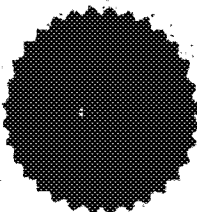

Pursuant to Title 8, Section 252(c) of the Delaware General Corporation Law, the undersigned corporation DOES HEREBY CERTIFY AS FOLLOWS:

FIRST: That the name and state of incorporation of each of the constituent corporations are as follows:

GE Infrastructure Sensing, Inc.	Delaware
GE NovaSensor Inc.	California

SECOND: That an Agreement and Plan of Reorganization and Merger (the "Merger Agreement") dated as of February 23, 2005 between GE NovaSensor Inc. ("NovaSensor") and GE Infrastructure Sensing, Inc. ("Infrastructure") setting forth the terms and conditions of the merger of NovaSensor with and into Infrastructure, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252 of the Delaware General Corporation Law.

THIRD: That the name of the surviving corporation (the "Surviving Corporation") shall be "GE Infrastructure Sensing, Inc.," a Delaware corporation.


