

Confirmation of Release of Security Interest in Patents

This CONFIRMATION OF RELEASE OF SECURITY INTEREST IN PATENTS, dated as of April 4, 2014 (this "Release"), is being furnished by Credit Suisse AG, in its capacity as collateral agent ("Collateral Agent") under the Credit and Guaranty Agreement, dated as of January 30, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified through the date hereof, the "Credit Agreement") by and among Alcatel-Lucent USA Inc., a Delaware corporation ("Grantor"), Alcatel-Lucent Holdings Inc., a Delaware corporation, Alcatel Lucent, a société anonyme incorporated under the laws of France ("Parent"), the Subsidiary Guarantors party thereto, the Lenders from time to time party thereto, Credit Suisse AG, as Administrative Agent and Collateral Agent, and the other Agents party thereto. Capitalized terms used herein without definition will have the meanings given to such terms in the Credit Agreement.

WHEREAS, on December 31, 2013 Parent entered into a definitive agreement for and closed on the sale of its interests in each of the patent families set forth on Exhibit I hereto, certain of which, as set forth on Exhibit X Tables 1 and 2 hereto, constitute Collateral under the Credit Agreement and Security Documents (such interests set forth on Exhibit X, collectively, the "Released Property") to Inventive Acquisition Company I, Inc. which is wholly owned by Interdigital, Inc.;

WHEREAS, for the patents listed on Exhibit X, Table 1, the U.S. Patent Security Agreement was recorded in the USPTO on March 7, 2013 at reel/frame number 030510/0627;

WHEREAS, for the patents listed on Exhibit X, Table 2, the U.S. Patent Security Agreement was recorded in the USPTO on January 30, 2013 at reel/frame number 029821/0001;

WHEREAS, Parent has advised the Administrative Agent and Collateral Agent that the sale of the Released Property is a permitted Asset Sale under Section 6.04(a) of the Credit Agreement and that such sale does not require approval by the Required Lenders; and

WHEREAS, in connection with the sale of the Released Property and in accordance with the terms of Section 9.08(a)(i) of the Credit Agreement, Parent has requested that Collateral Agent execute this Confirmation of Release and other documentation effecting the release of its Liens encumbering the Released Property (collectively, the "Release Documents").

NOW THEREFORE, effective December 31, 2013, (the "Release Time"), to the extent not already released, Collateral Agent hereby releases, relinquishes and discharges, with respect to Grantor, all of its continuing security interest in all Grantor's right, title or interest in and to the Released Property and re-assigns to Grantor any and all right, title or interest it may have in and to such Released Property, all without warranty, representation or recourse of any kind. Collateral Agent hereby authorizes Grantor, Grantor's authorized representatives or any subsequent owner or successor-in-interest to the patents listed on Exhibit X as collateral to, upon and after the Release Time: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and to record this release in any foreign patent offices and/or (b) file, at Grantor's sole cost and expense, UCC financing statement terminations or amendments in a form and substance reasonably consented to by Collateral Agent with the applicable filing offices in order to memorialize the release of the security interest of Collateral Agent solely in the patents listed on Exhibit X.

Notwithstanding anything to the contrary contained in the Release Documents, except as expressly and specifically set forth in the Release Documents, the Security Documents and the security interests and Liens granted thereby shall remain in full force and effect.
