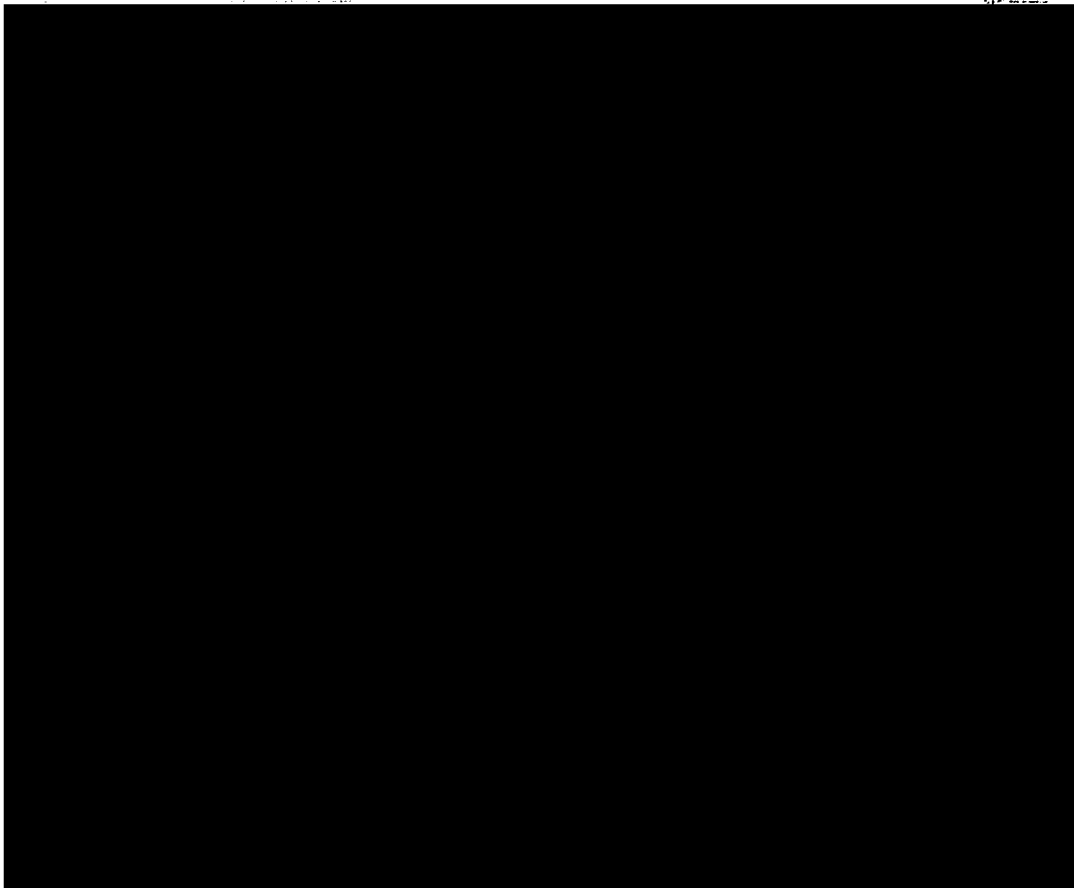
CONVEYANCE, ASSIGNMENT AND ASSUMPTION

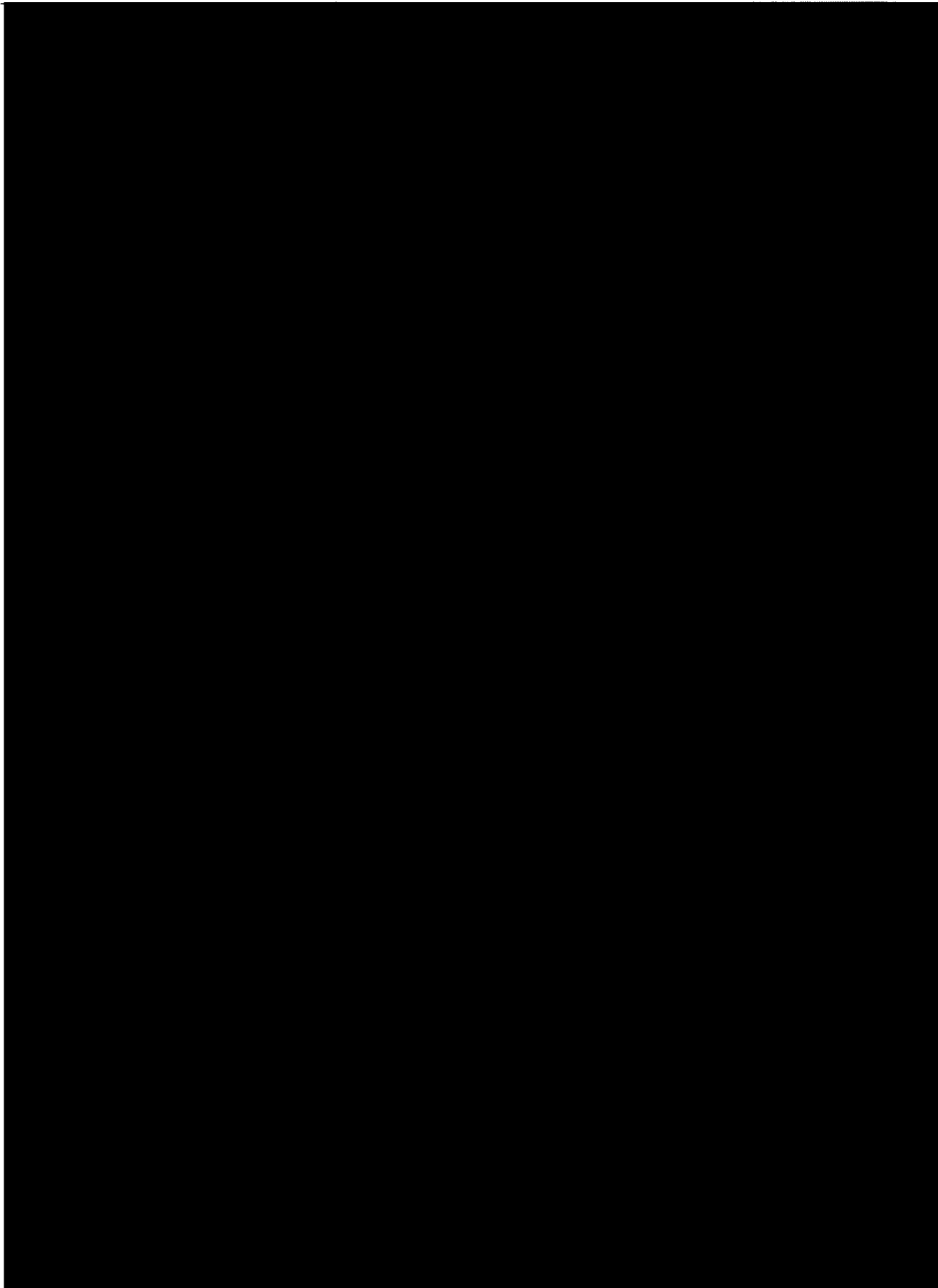
This Conveyance, Assignment and Assumption (this "Conveyance"), effective as of September 1, 2013 (the "Effective Date"), is from **GENBAND IRELAND LIMITED**, an Irish limited company (herein called "Grantor"), and in favor of **GENBAND US LLC**, a Delaware limited liability company (herein called "Grantee"). Grantor and Grantee are sometimes individually referred to herein as a "Party" and collectively referred to as the "Parties."

ARTICLE I GRANTING AND HABENDUM CLAUSES

1.1 Granting Clause. For good and valuable consideration (including the consideration set forth in Section 1.2 below), the receipt and sufficiency of which Grantee hereby acknowledges, Grantor hereby contributes, conveys, assigns, transfers, delivers, and sets over unto Grantee, its successors and assigns, all right, title, interests and estate of Grantor in and to the Purchased Intellectual Property (as defined in the Fring Asset Purchase Agreement). "Fring Asset Purchase Agreement" means the Asset Purchase Agreement, dated August 29, 2013, by and between GENBAND Ireland Ltd. and Fringland Ltd. and, solely for purposes of Section 7.6 of the Asset Purchase Agreement, GENBAND Israel Ltd.

The property described in this Section 1.1 shall be referred to herein collectively as the "Subject Property."
