ASSIGNMENT AND AGREEMENT

WHEREAS, Brennon L. White of 2950 Woodbury Blvd, Commerce, MI 48390, and Mary J. Lumbard of 3422 Pineview Drive East, Dexter, MI 48130, and Anne P. Liss of 35258 Hathaway Street, Livonia, MI 48150, and William G. 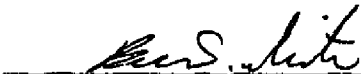

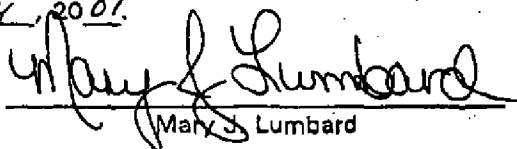
