## ASSIGNMENT

WHEREAS, WE, Takao ENDOH, a citizen of Japan, residing at c/o KABUSHIKI KAISHA ISOWA, 66, Nishiya-cho, Kasugai-shi, Aichi, Japan, hereinafter referred to as ASSIGNORS, have invented certain new and useful improvements in

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives

and assigns, to obtain and enforce proper patent protection for the improvements in all countries.

AND WE HEREBY grant to Steven B. Pokotilow, Lawrence Rosenthal, Pierre R. Yanney, Irah H. Donner, Matthew W. Siegal, Brian M. Rothery, Ian G. DiBernardo, Angie M. Hankins, Charles E. Cantine and Jeffrey Mann, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this Assignment.
