

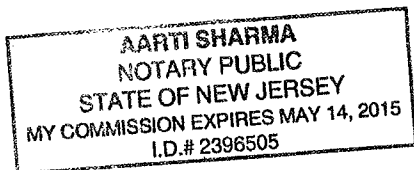

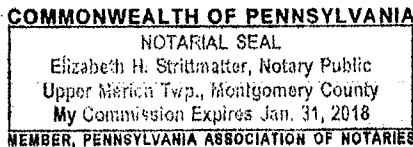

PTC CONFIDENTIALITY AND ASSIGNMENT OF INVENTIONS AGREEMENT

In consideration of my employment or continued employment with PTC, my compensation and other benefits and the promises contained in this Agreement, PTC and I agree as follows:

1. **Background.** PTC is a corporation currently engaged in the discovery, development and potential distribution of drugs, diagnostics, and related health care products and services. I acknowledge that as part of my employment with PTC I may have access to Confidential Information or Develop Inventions. The purpose of this Agreement is to protect Confidential Information and Inventions that belong to PTC, as well as to specify other terms and conditions relating to the services I perform for PTC.

2. **Confidential Information.** In this Agreement, "Confidential Information" means all trade secrets, proprietary information and materials of PTC and any information used, developed or acquired by me in connection with my services for or employment by PTC, if the information is not generally available to the public, regardless of whether the information is protected by patent or copyright. Confidential Information is not limited to information which is specifically marked as "confidential." Examples of Confidential Information include, but are not limited to, discoveries, inventions, developments, concepts, chemical structures, ideas, business plans or strategies, methods, processes, research, marketing plans, sales prospects, financial information, details of employee compensation, and information relating to actual or potential customers, partners, suppliers, investors, licensors, licensees and affiliates of PTC.

I acknowledge that Confidential Information represents a valuable trade and business secret and special asset of PTC. I acknowledge that all Confidential Information is, and shall continue to be, the exclusive property of PTC, whether or not prepared in whole or part by me and whether or not disclosed to me or entrusted to me in connection with my work for PTC. I understand that disclosure of Confidential Information to parties other than PTC without the written consent of an officer of PTC may cause serious and irreparable injury to PTC.

I will never directly or indirectly use Confidential Information except as required in connection with the performance of my duties as an employee of PTC, nor will I directly or indirectly disclose or disseminate Confidential Information to any third party without the prior written consent of an officer of PTC. Even where I obtain the authorization to disclose Confidential Information to a third party, I agree to use my best reasonable efforts to minimize any risks of inappropriate disclosure of the information through the use of nondisclosure agreements and careful handling of materials.

3. **Inventions.** In this Agreement, "Inventions" means all trade secrets, discoveries, inventions, innovations, improvements, developments, concepts, ideas, know-how, software and all other forms of intellectual property, whether

or not any of the foregoing is patentable or unpatentable or protected or capable of protection under the copyright or intellectual property laws and whether or not any of the foregoing constitutes trade secrets or confidential information, which I Develop.

In this Agreement, "Develop" means conceive, develop or reduce to practice either alone or as a joint inventor.

Each and every Invention I Develop during my employment with or period I perform services for PTC shall be and remain the sole and exclusive property of PTC without additional consideration or compensation to me, except for any Invention which meets all of the following criteria: (i) no equipment, supplies, facility or Confidential Information was used in Developing the Invention, (ii) the Invention was Developed entirely on my own time, (iii) the Invention relates neither to the business of PTC, nor to PTC's actual or demonstrably anticipated research or development, nor to any work performed by me for PTC.

I will keep complete written records of all Inventions I Develop during the time I am employed by or perform services for PTC and will promptly disclose all Inventions to PTC in writing for the purpose of enabling PTC to adequately determine its rights in each Invention. I will supplement any such disclosure to the extent PTC may reasonably request. If I have any doubts as to whether or not to disclose an Invention to PTC, I will disclose it. If I assert any property right in any Invention, I will promptly notify PTC in writing of that fact. I further represent that to the best of my knowledge none of the Inventions that are the property of PTC under this Agreement will infringe upon any third party right.

I will promptly and completely disclose to PTC in writing all Inventions which I Develop during the one-year period immediately following the end of my employment with or date I stop performing services for PTC, whichever is later, which relate either to my work assignment at PTC, or to Confidential Information, for the purpose of determining whether PTC has rights in such Invention. I will not file any patent application relating to such Invention without the prior written consent of PTC. If it is shown that the Invention was not made by me entirely after leaving PTC, the Invention will be presumed to have been Developed during the time I was employed by or performed services for PTC. I acknowledge that the conditions of this paragraph are no greater than necessary for protecting PTC's interest in Confidential Information and in Inventions to which it is rightfully entitled.

Both during and after my employment with PTC, I will assist and fully cooperate with PTC, its attorneys and agents in obtaining and maintaining the fullest measure of legal protection which PTC elects to obtain and maintain for Inventions in which it has a property right. I will execute any lawful document (including, but not limited to, applications, assignments, oaths, declarations and affidavits), make myself available for interviews, depositions and testimony relating to

any Invention and join in any proceeding requested by PTC relating to any Invention. I further designate PTC as my agent for, and grant to PTC a power of attorney with full power of substitution, which power of attorney shall be deemed coupled with an interest, for the purpose of effecting the foregoing assignments from me to PTC. PTC agrees to bear the expenses which it causes to be incurred in my assisting and cooperating hereunder.

On Schedule A, incorporated into and made a part of this Agreement, I have completely identified (without disclosing any trade secret or other confidential information) every Invention Developed before my employment or services to PTC in which I have an ownership interest and which is not the subject matter of an issued patent or printed publication at the time I sign this Agreement. If I become aware of any projected or actual use of any such Invention by PTC, I will promptly notify PTC in writing of said use. Except as to the Inventions listed on Schedule A, or those which are the subject matter of an issued patent or publication at the time I sign this Agreement, I will not assign or assert any rights against PTC with respect to any Invention Developed before my employment with or services to PTC in which I have an ownership interest.

4. Non-Competition and Non-Solicitation. During my employment with PTC, I will not directly or indirectly, either as an employee, consultant, agent, principal, partner, stockholder, corporate officer, director, or in any other individual or representative capacity, engage or participate in any business or activity that is competitive with the business of PTC.

Both during my employment with PTC and for at least one-year thereafter, I will not (i) solicit, divert or take away, or attempt to solicit, divert or take away the business of or any actual or potential business dealings or relationships with PTC or (ii) encourage or solicit any employee to leave the employ of PTC.

5. Return of Property. Upon my termination of employment with PTC or whenever requested by PTC, I shall immediately deliver to PTC all property of PTC without keeping any copies thereof including, without limitation, records, reports, drawings, manuals, documents, photographs, notes, (including, without limitation, any of the foregoing recorded on any computer or any machine readable medium), keys, identification badges, products and materials.

6. Prior and Future Employers. I will provide and, PTC may similarly provide in its discretion, a copy of the covenants contained in Sections 2 through 5 of this Agreement to any business or enterprise with which I may be connected as an owner, officer, director, employee, partner, principal, agent, representative, consultant or otherwise.

On Schedule B, incorporated and made a part of this Agreement, I have listed and attached copies hereto of any agreements with any other party which may prevent my full compliance with the terms stated in this Agreement. I represent that, except as provided in Schedule A or B, I have no commitments or obligations inconsistent with this Agreement or which would prevent me from fully performing my responsibilities for PTC.

I acknowledge that PTC is not employing me to obtain any information which is the property of any previous employer or any others for whom I have performed services. I will not, in performing services for PTC, make use of information which is the property of or confidential to any previous employer or other person or entity for whom I have furnished services.

7. Reimbursement of Funds. Upon termination, I shall properly account for funds advanced or entrusted to me and will promptly reimburse PTC for amounts due. I authorize PTC to deduct from my pay, upon termination of employment, any amounts rightfully due PTC consistent with applicable law.

8. Employment at Will. I understand and agree that the employment relationship between PTC and me is an employment at will relationship. As such, I understand and agree that my employment by PTC is not for any definite period, but may be terminated either by me or PTC at any time.

9. Conflict of Interest. I will not engage in any outside employment or other activity which could give rise to a conflict of interest, diminish the effectiveness of my performance or reflect adversely on PTC. This specifically includes, without limitation, engaging in outside employment or another activity which might require the use of PTC property or Confidential Information or simultaneous other employment in a line of business that is in conflict or competition, in whole or in part, with any of PTC's line of business. The giving of speeches or presentation of papers or acting as an instructor or seminar leader where PTC's name is or could be involved must either be approved in advance by PTC or come within the terms of PTC's written policy on publications and presentations.

10. Miscellaneous.

(a) "PTC" collectively identifies PTC Therapeutics, Inc., its affiliated companies, predecessors, successors and assigns.

(b) I agree that any breach or threatened breach by me of this Agreement may result in substantial and irreparable damage to PTC and I agree that in such a case, PTC is entitled to seek an injunction to restrain the breach. PTC remains entitled to any other remedies available at law or equity. Without limiting the foregoing, I understand and agree that I will be held responsible for any liability PTC may suffer as a result of Inventions, agreements or obligations I fail to disclose in Schedule A or B.

Should a claim be brought by PTC or me for breach of this Agreement, the losing party shall pay the other party's costs and expenses resulting therefrom or incurred in enforcing this Agreement, including, but not limited to legal fees and court costs.

(c) This Agreement shall be construed in accordance with the laws of the State of New Jersey, without regard to conflict of laws principles. Any legal action or proceeding with respect to this Agreement shall be brought in a court of competent jurisdiction in New Jersey and I and PTC accept the jurisdiction of a court in New Jersey.

(d) As of the effective date of this Agreement, this Agreement embodies the entire agreement between PTC and me with respect to the subject matter hereof and, as of the effective date of this Agreement, supersedes all prior oral or written agreements and understandings relating to such subject matter. I understand and agree that this Agreement can only be amended by a writing signed by me and an officer of PTC. No failure or delay by me or PTC in exercising any right or remedy under this Agreement, and no course of dealing between the parties shall operate as a waiver of any such right or remedy or any future right or remedy. The rights and benefits of this Agreement shall inure to the benefit of and be enforceable by PTC and its successors and assigns. I understand that this Agreement may not be assigned by me.


(e) If any part or parts of the Agreement are deemed illegal, invalid or unenforceable by a court of competent jurisdiction, such judgment shall not affect the validity of the balance of the terms of this Agreement which shall remain in full force and effect, and in lieu of each such illegal, invalid or unenforceable provision, there shall be added automatically, as part of this Agreement, a provision similar in terms to such illegal, invalid or unenforceable provision as may be possible and legal, valid and enforceable.

(f) The headings of the various provisions of this Agreement are for convenience of reference only and shall in no way modify or affect the meaning or construction of any of the terms of this Agreement.

(g) I understand and agree that my obligations to PTC under this Agreement continue throughout the entire period of time I am employed by or provide services to PTC and will survive the end of my employment with or services for PTC.
