**RELEASE OF**  
**AMENDED AND RESTATED PATENT SECURITY AGREEMENT**

THIS RELEASE OF AMENDED AND RESTATED PATENT SECURITY AGREEMENT (this “Release”), dated as of April 24, 2014 is made by **FIFTH THIRD BANK**, an Ohio banking corporation, in its capacity as Agent for the benefit of the Secured Creditors (“Agent”), and is as follows:

WHEREAS, MUZZY OUTDOORS, LLC, a Delaware limited liability company (“Debtor”), and Agent are parties to that certain Patent Security Agreement dated as of May 16, 2013, which was recorded with The United States Patent and Trademark Office on May 28, 2013 in its records at Reel 030498, Frame 0815, as amended by the First Amendment to Patent Security Agreement dated as of August 13, 2013, which was recorded with The United States Patent and Trademark Office on September 4, 2013 in its records at Reel 031157, Frame 0203, as the foregoing was amended and restated in its entirety by that certain Amended and Restated Patent Security Agreement dated as of December 20, 2013, which was recorded with The United States Patent and Trademark Office on January 29, 2014 in its records at Reel 032136, Frame 0706 (collectively, the “Agreement”); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Agent a security interest in all of the Debtor’s right, title and interest in, to and under the Patent Collateral, including, without limitation, (a) all of Debtor’s right, title and interest in and to all of its now owned or in the future owned or existing patents and patent applications, including the inventions and improvements described and claims in those patents and patent applications listed on Schedule I attached hereto and made a part hereof (the property in this item (a) being, each, a “Patent”, and collectively, the “Patents”); (b) all reissues, divisions, continuations, renewals, extensions and continuations in part of each of the Patents; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Patents, including damages and payments for past or future infringements of any and all of the Patents; (d) all rights to sue for past, present and future infringements of any and all of the Patents; (e) all of Debtor’s rights corresponding to each of the Patents throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, any patents or patent applications, including the licenses listed on Schedule I and the Patent Licenses; and (g) all books, records, cash and non-cash proceeds of any and all of the foregoing; and

WHEREAS, Agent desires to release its rights and security interests in the Patent Collateral.


