ASSIGNMENT OF PATENT RIGHTS

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, we, the Applicants, by these presents do hereby sell, assign, transfer and set over unto said assignee the full and exclusive right, title and interest to the said invention and all non-provisional patent applications claiming the benefit and/or priority of common subject matter of said invention, all continuations, divisions, substitutions, continuations-in-part thereof, and all United States Letters Patents which may be granted thereon and all reissues and extensions thereof, and all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said improvements in any foreign countries and we hereby authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patents for said improvements to said assignee, the entire right, title, and interest in and to the same, for his sole use and behoof and for the use and behoof of his legal representatives, to the full end of the term for which said Patent may be granted, as fully and entirely as

the same would have been held by us had this assignment and sale not been made in accordance with the terms of this assignment.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;


AND WE HEREBY further covenant and agree that we will communicate to Assignee any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible and reasonable to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.




