GENERAL JUDGMENT AND
MONEY AWARD

This action came regularly before the undersigned judge of the above-entitled Court. Plaintiff appeared through its attorney, Dirk Doyle, and Defendants did not appear through an attorney. Thereafter, testimony and other evidence were introduced by the Plaintiff concerning the existence of a contract, and the amount owed Plaintiff for its performance of its obligations under that contract. The Court, being fully advised, concludes that a contract existed between the parties, and that Defendants are indebted to Plaintiff for Plaintiff's performance.

IT IS ORDERED AND ADJUDGED that Defendants' Counterclaims in the above-entitled action be dismissed with prejudice, and in their entirety, because Defendants failed to appear through an attorney to prosecute Defendant's Counterclaims.

IT IS FURTHER ORDERED AND ADJUDGED that Plaintiff have judgment against Defendants in the sum of \$45,000.00, together with pre-judgment interest running from January 1, 2012, and post-judgment interest running from the date of entry of the judgment, at the rate of 1.5% per month, and attorney fees, and costs and disbursements in the sum of \$5680.00, on Plaintiff's First Cause of Action.


