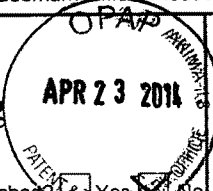

PATENT ASSIGNMENT AGREEMENT

THIS AGREEMENT is made this 18th day of March, 2014 by and between William Peter Ginsberg ("Assignor"), whose business address is 1520 Vaila Circle, LV, NV 89101 and Magic Photo, LLC ("Assignee", and collectively, the "Parties"), whose business address is 3440 W. Cheyenne Ave. # 500, North Las Vegas, NV 89032.

WHEREAS, Inventor has invented A Laser Photo Process that creates high resolution Photo within a Mirror (the "Invention"), and has been granted United States Letters Patent for said invention, Patent No. US 6,543,163 (the "Patent"), granted on the patent application filed with the United States Patent and Trademark Office, Patent Application Number Serial No.: 10/009,935 filed November 5, 2001.

WHEREAS, Assignee wishes to acquire all right, title and interest in the Patent, and Assignor wishes to sell its interest in the Patent to Assignee.

NOW THEREFORE, in consideration of the mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, the Parties agree as follows:

1. **Assignment.** Assignor hereby assigns to Assignee, and its successors, representatives and assigns, all right, title and interest in the Patent including all reexaminations, extensions and reissues thereof. Assignor hereby requests the Commissioner of Patents of the United States to record this assignment of all right, title and interest in the Patent to Assignee.
2. **Payment.** In consideration of the assignment of the Patent pursuant to this Agreement, and of the promises and covenants contained herein, Assignee of Assignor has an interest in shall use it's best efforts to produce income in which.
3. **Assignor's Representations and Warranties.** Assignor hereby represents and warrants that he has the legal right and authority to execute this Agreement, and to validly assign the entire interest in the Patent to Assignee. If any provision of this Agreement is deemed invalid or unenforceable by any court of competent jurisdiction, and if limiting such provision would make the provision valid, then such provision shall be deemed to be construed as so limited.

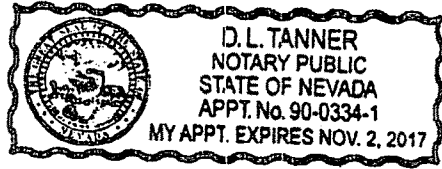
