

"ARTICLE I

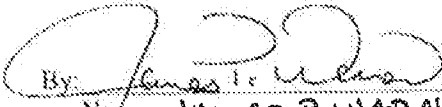
The name of the corporation is Anchor Glass Container Corporation (the "Corporation")."
