ASSIGNMENT

WHEREAS, Yakima Products, Inc. (YPI), a Delaware corporation, having its principal place of business in Beaverton, Oregon, is the assignee of 100% interest of U.S. Patent Application Serial No. 11/501,929 filed August 8, 2006; and

WHEREAS, Yakima Innovation Development Corporation (YIDC), a Cayman Island company, having its principal place of business in Georgetown, Grand Cayman, Cayman Islands, is desirous of acquiring an interest therein;

YPI hereby authorizes and requests the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to YIDC, as the assignee of YPI's entire right, title, and interest in and to the same, for the sole use of YIDC, and its successors and assigns.

Further, YPI hereby covenants and agrees to and with YIDC, and its successors and assigns, at the time of execution and delivery of these presents, that YPI is the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified patent application, and that the same are unencumbered, and that YPI has good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, YPI agrees that it will communicate to YIDC, or its representatives, any facts known to me respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to YIDC, make all rightful oaths, and generally do everything

possible to aid YIDC, and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
