its successors, legal representatives and assigns, shall advise: that any proceeding in connection with the Letters Patent or Patent Applications of the United States, including but not limited to interference proceedings, is lawful and desirable; or any reissue, reexamination or extension of any Letters Patent, to be obtained thereon, is lawful and desirable.
