## PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of May 14, 2014, by ANTARES CAPITAL CORPORATION ("**Agent**").

### WITNESSETH:

WHEREAS, Agent and SWITCHCRAFT, INC., an Illinois corporation ("**Grantor**"), were parties to that certain Patent Security Agreement, dated as May 28, 2010 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain patents (the "**Patents**") and Patent Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Patents set forth on Schedule 1 hereto; and

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "**Patent Rights**"):

(a) each Patent, including, without limitation, the issued Patents (together with any reissues, divisions, continuations, renewals, extensions or continuations-in-part thereof), pending Patent applications referred to in Schedule 1 annexed hereto, and all of the inventions and improvements described and claimed in each Patent, Patent registration and Patent application together with all patentable inventions;

(b) each Patent license, including without limitation each Patent license listed on Schedule 1 annexed hereto; and


(c) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent including, without limitation, the issued Patents referred to in Schedule 1 annexed hereto, the Patents issued from any pending Patent applications referred in Schedule 1 and the Patents licensed under any Patent license.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Patents and the Patent Rights.
