INTELLECTUAL PROPERTY PURCHASE AGREEMENT

THIS intellectual property purchase agreement (the "**Agreement**") effective as of Effective Date (as set out in Schedule "A")

BETWEEN:

VIGNETTE CORPORATION, a corporation incorporated under the laws of Delaware,

(the "**Vendor**")

- and -

VIGNETTE LLC, a limited liability company formed under the laws of Delaware

(the "**Purchaser**")

RECITALS:

- A. The Vendor is the owner of the intellectual property and other assets more particularly described on Schedule "B" (collectively, the "**Purchased Intellectual Property**").
- B. The Vendor wishes to transfer the Purchased Intellectual Property to the Purchaser to facilitate the integration and centralization of the global intellectual property of the Vendor.
- C. The Vendor desires to sell and the Purchaser desires to purchase the Purchased Intellectual Property upon and subject to the terms and conditions in set forth in this Agreement.

THEREFORE, IN CONSIDERATION of the premises and the covenants and agreements in contained in this Agreement, the Vendor and the Purchaser (individually, a "**Party**", collectively, the "**Parties**") agree as follows:

1. Purchase and Sale - The Vendor hereby sells to the Purchaser and the Purchaser hereby purchases from the Vendor the Purchased Intellectual Property.
2. Effective Date and Time - The effective date and time of the sale transaction relating to the Purchased Intellectual Property shall be the Effective Date at the time set out in Schedule "A" (the "**Effective Time**").
3. Consideration- The purchase price for the Purchased Intellectual Property shall be equal to the fair market value of the Purchased Intellectual Property, being the amount set out in Schedule "A" (the "**Purchase Price**").
4. Payment of Purchase Price - The Purchase Price shall be satisfied in full by issuance by the Purchaser to the Vendor of the percentage and class of member Limited Liability Company Interests as set out in Schedule "A" (the "**Interests**").

5. Corporate Authority and Approval. The Vendor represents and warrants to the Purchaser as follows:
- (a) the Vendor is the owner of the Purchased Intellectual Property and, subject to the rights of licensees of the Purchased Intellectual Property, has the exclusive right to use, sell, license and dispose of, and has the right to bring actions for infringement of and the right to receive the proceeds and revenue from the exploitation of, the Purchased Intellectual Property without payment of any royalty or other fees;
 - (b) the Vendor has the corporate power and authority to enter into this Agreement, and all of the instruments and transfers to be executed and delivered as contemplated by this Agreement;
 - (c) the execution and delivery of this Agreement and all such other agreements, instruments and documents and the completion of the transactions contemplated by this Agreement have been duly authorized by all necessary corporate action of the Vendor; and
 - (d) the Vendor has taken all steps and obtained all approvals which may be necessary or advisable to effect the transfer of the Purchased Intellectual Property to the Purchaser.
6. Enforceability of Vendor's Corporate Obligations - The Vendor represents and warrants to the Purchaser that this Agreement and each of the agreements, documents and instruments contemplated by this Agreement to which the Vendor is a party constitute valid and binding obligations of the Vendor, enforceable in accordance with their respective terms, subject to usual exceptions in respect of bankruptcy, etc. and in respect of the availability of equitable remedies and defences. The execution, delivery and performance of this Agreement by the Vendor and each of the agreements, documents and instruments contemplated by this Agreement, as applicable, does not and will not:
- (a) contravene or conflict with or constitute a violation of any provision of any law or regulation binding upon or applicable to the Vendor;
 - (b) contravene or conflict with or constitute a violation of any provision of agreement to which the Vendor is a party; or
 - (c) contravene or conflict with or constitute a violation of any judgment, injunction, order or decree binding upon or applicable to the Vendor.
7. Ownership of Intellectual Property - The Vendor represents and warrants to the Purchaser that:
- (a) no person other than the Purchaser has any agreement, option, right or privilege capable of becoming an agreement for the purchase from the Vendor of any of the Purchased Intellectual Property; and
 - (b) following the execution and delivery of this Agreement and instruments and documents contemplated hereby, the Purchaser shall have acquired good and marketable titled in and to the Purchased Intellectual Property free and clear of all encumbrances.
8. Purchaser's Representations - The Purchaser represents and warrants to the Vendor as follows:

- (a) the Purchaser has the power and authority to enter into this Agreement, and all of the instruments and transfers to be executed and delivered as contemplated by this Agreement;
 - (b) the execution and delivery of this Agreement and all such other agreements, instruments and documents and the completion of the transactions contemplated by this Agreement have been duly authorized by all necessary corporate action of the Purchaser; and
 - (c) the Purchaser has obtained all approvals as may be required to authorize the issuance of the Interests by the Purchaser to the Vendor.
9. Fair Market Value - The Parties confirm their intention that the Purchase Price for the Purchased Intellectual Property be equal to the fair market value of the Purchased Intellectual Property as at the Effective Date and that they have made a bona fide attempt to determine the fair market value of the Purchased Intellectual Property based upon what they consider to be generally accepted accounting and valuation principles.
10. Tax Authority Purchase Price Adjustment - If any taxing authority having jurisdiction alleges that the Purchase Price for the Purchased Intellectual Property is not the fair market value of the Purchased Intellectual Property as at the Closing Date, or proposes to make an assessment of tax on the basis that any gift, benefit or advantage is or has been conferred on any person by reason of the transfer of the Purchased Intellectual Property by the Vendor to the Purchaser or the issuance of the Interests by the Purchaser to the Vendor, or takes any other steps or makes any other rulings of general application or specific to one of the Parties which may be prejudicial to any of the Parties, or if the Parties, subsequent to the Effective Date, determine, acting in good faith, that there has been a material miscalculation in their original calculation of the Purchase Price, the Parties may, after consultation with such taxing authority, or as the Parties may agree, acting in good faith, adjust the Purchase Price for the Purchased Intellectual Property and/or the percentage of the applicable class of Interests issued in respect of the transfer of the Purchased Intellectual Property to such other amount as may be determined by the Parties after such consultation or reconsideration so that the Purchase Price for the Purchased Intellectual Property and/or the percentage of the applicable class of Interests issued in respect of the transfer of the Purchased Intellectual Property shall mean such adjusted amount and make such other adjustments as may be reasonable or necessary under the circumstances, all of which adjustments shall be deemed to have been made, *nunc pro tunc* where permitted, otherwise any such adjustment shall be made in the current fiscal period. Further, the Parties agree that any adjustments made hereunder to the percentage of Interests issued in a particular class shall be applied in the same proportion to that originally allocated on Schedule "A" hereto.
11. Assignment - The Parties agree that the rights, obligations and duties of each of them hereto may not be assigned without the written consent of the other Party hereto.
12. Governing Law - The Parties agree that this Agreement shall be construed and enforced in accordance with, and the rights of the parties shall be governed by, the laws in force in the jurisdiction set out in Schedule "A".
13. Counterparts - This Agreement and the documents to be delivered under this Agreement may be executed in any number of counterparts (including counterparts by facsimile or other electronic transmission) and all such counterparts taken together shall be deemed to constitute one and the same instrument. The reproduction of signatures by facsimile or other electronic means will be treated as binding as if originals and each Party undertakes to provide each and every other Party


with a copy of the Agreement and any such documents bearing original signatures forthwith upon demand. This Agreement and such documents shall become effective when each Party shall have received a counterpart thereof signed by the other Parties thereto.


14. Severance - Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction shall, as to that jurisdiction, be ineffective to the extent of such prohibition or unenforceability and shall be severed from the balance of this Agreement, all without affecting the remaining provisions of this Agreement or affecting the validity or enforceability of such provision in any other jurisdiction.
15. Entire Agreement - This Agreement constitutes the entire agreement between the Parties pertaining to the subject matter of this Agreement and supersedes all prior agreements, understandings, negotiations and discussions, whether oral or written. There are no conditions, warranties, representations or other agreements between the Parties in connection with the subject matter of this Agreement (whether oral or written, express or implied, statutory or otherwise) except as specifically set out in this Agreement.
16. Enurement - The Parties agree that this Agreement shall enure to the benefit of and shall be binding upon the Parties and their respective personal representatives, heirs, successors and permitted assigns.
17. Further Assurances - The Parties agree to do all acts and things, including the executing of such further and other documents and assurances, as is necessary to give full effect to the provisions of this Agreement.



- (b) the Patents (as such term is defined below);
- (c) all inventions, patents, patent rights, patent applications, utility models (including all applications, reissues, divisions, continuations, continuations-in-part, revisions, supplementary protection certificates, extensions and re-examinations of any patent, patent application or utility model) and all equivalent or similar rights anywhere in the world in inventions and discoveries including invention disclosures Related to the Business (as such term is defined below);
- (d) all right, title and interest in the internet addresses Related to the Business, including, without limitation "Vignette.com", and all past and present sub-trees under the such addresses and all domain names and sites and applications and registrations therefor;
- (e) all registered and unregistered trade-marks (whether used with wares or services and including the goodwill attaching to such trade-marks), service marks, trade names, trade dress, logos, business, corporate and product names and slogans and registrations and applications for trade-marks (and all future income from such trade-marks), Related to the Business;
- (f) all copyrights in copyrightable works, all non-copyrightable works, and all other rights of authorship, worldwide, and all applications, registrations and renewals in connection therewith Related to the Business;
- (g) all rights and interests in and to processes, lab journals, notebooks, data, trade secrets, designs, know-how, product formulae and information, manufacturing, engineering and other drawings and manuals, Technology (as such term is defined below), blue prints, research and development reports, agency agreements, technical information, engineering data, design and engineering specifications, and similar materials recording or evidencing expertise or information Related to the Business;
- (h) all of the intellectual property registered under the registrations and applications for registration listed in Schedule "B-3" and (ii) and the permissions and licenses listed in Schedule "B-3"; and
- (i) all licenses (end-user or otherwise) of the intellectual property listed in paragraph (a) to (i) above;

"Patent" means:

- (b) any reissue, division, continuation, continuation in part, extension, re-examination, or disclaimer, of any patent or application listed in Schedule "B-2";

- (f) all confidential or proprietary information relating to any of the above;

"Related to the Business" means, directly or indirectly, used in, arising from or relating in any manner to the business of Vignette Corporation as conducted immediately prior to the Effective Date;

"Technology" means all works of authorship including without limitation, computer programs and computer software, completed or in the course of development or further development by or on behalf of the Vendor including for greater certainty the computer software applications set out in Schedule "B-1", which includes all releases, versions, modifications, updates, improvements and accessions thereto and all source code, executable code and other materials whether embodied in software, firmware, documentation, designs, methods, techniques, processes, files, industrial models, schematics, specifications, net lists, build lists, records, data or otherwise relating thereto and including all databases and documentation relating to the foregoing but excluding any software or other material licensed by the Vendor from any third party;
