DISSOLUTION WITHOUT LIQUIDATION

Rhodia Opérations, a simplified joint-stock company with capital of €88 112 895, having its registered office at 40 rue de la Haie Coq, Aubervilliers (93300), registered at the Bobigny Commercial and Companies Register under number 622 037 083, has acquired all the company shares of Rhodia Recherches et Technologies, a simplified joint-stock company with capital of €26 443 500, having its registered office at 52 rue de la Haie Coq, Aubervilliers (93300), registered at the Bobigny Commercial and Companies Register under number 322 346 669.

In its capacity as sole partner, Rhodia Opérations has informed Rhodia Recherches et Technologies that it intended to dissolve the latter company under the provisions of Section 1844-5, paragraph 3, of the French Civil Code.

**DECLARATION OF THE DISSOLUTION WITHOUT LIQUIDATION
OF RHODIA RECHERCHES ET TECHNOLOGIES**

As a result of what has been stated above, Mr Gilles Auffret, acting as Chairman of Rhodia Opérations, the sole partner of Rhodia Recherches et Technologies, declares the following:

1. That Rhodia Recherches et Technologies is being dissolved pursuant to Section 1844-5, paragraph 3, of the French Civil Code, this dissolution involving the complete transfer of the assets of Rhodia Recherches et Technologies without any liquidation taking place, subject to the sole proviso that, at the end of the thirty-day period for opposition which runs from the date on which this decision is published in a journal of legal notices, the creditors have not opposed the dissolution or, in the event of oppositions, that they have been refused at first instance or that the repayment of the debts has been made or guarantees established.

This dissolution shall be published and registered at the Bobigny Commercial Register in accordance with the applicable legal provisions.

2. That, as a result of this dissolution without liquidation, Emmanuel Murgue and Vincent Fremin are appointed for the following purposes, with power to act separately:

- arranging for the publication of this decision in a journal of legal notices on 1 June 2007, in order for the thirty (30)-day period for opposition by creditors to start running,
- if applicable, noting the absence of opposition by the creditors to this dissolution decision on the expiry of the abovementioned period, signing the non-opposition declaration, noting the full transfer of the assets of Rhodia Recherches et Technologies to Rhodia Opérations, as well as the disappearance of Rhodia Recherches et Technologies as a legal entity and arranging for it to be deleted from the Commercial and Companies Register,

- in the event of opposition by one or more creditors, noting the dismissal of the oppositions or the establishing of guarantees ordered by judicial decision,
- if applicable, confirming and repeating, by any private agreements or authentic documents, the transfer of the assets of Rhodia Recherches et Technologies to Rhodia Opérations, where necessary, specifying the name, making good any omissions or inaccuracies, establishing and completing all roots of title;
- carrying out the transfer from Rhodia Recherches et Technologies to Rhodia Opérations of the following:
 - . all patent applications and patents in the name of Rhodia Recherches et Technologies as well as the priority rights attached to those patent applications and/or patents, and
 - . the right to commence, continue or resume in its name any proceedings based on those patent applications and/or patents, particularly infringement proceedings or proceedings for compensation in respect of the loss suffered, even in respect of events predating this document; and
 - . the right to commence, continue or resume in its name any opposition proceedings against third-party patents in the relevant patent offices,
- representing Rhodia Recherches et Technologies in court proceedings, as well as before any administrations and public authorities,

representing it in any arrangement proceedings or judicial or private liquidation proceedings and making any declarations regarding debts,

- in general, taking any decisions, signing any documents and carrying out any formalities required by this decision and the subsequent transfer of assets,

3. Pursuant to these presents and the abovementioned law, taking over all the commitments and obligations for Rhodia Recherches et Technologies with regard to its co-contractors and, in general, with regard to third parties, as well as all the rights previously enjoyed by the dissolved company.
