Patent Assignment

Whereas, **Sanders Industries**, a California corporation, located at 3701 Conant Street, Long Beach, California 90808 ("Assignor"), has acquired all right, title and interest in and to the currently pending applications and issued patents listed on Exhibit A attached hereto (the "Properties");

Now, therefore, for other good and valuable consideration, Assignor, by these presents does hereby sell, assign, and transfer unto Assignee, its successors, assigns, and legal representatives the full and exclusive right to the Properties in the United States and the entire right, title, and interest in and to any and all Patents which may be granted therefor and/or therefrom in the United States, to all divisions, reissues, substitutions, continuations, continuations-in-part, and extensions of said Properties. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents for the currently pending applications listed on Exhibit A, or patents resulting therefrom, insofar as Assignor's interests are concerned, to Assignee, of the entire right, title, and interest in and to the same, for its sole use and benefit; and for the use and benefit of its legal representatives, to the full end of the term for which said Patent(s) may be granted, as fully and entirely as the same would have been held by the Assignor had this assignment not been made.

Assignor also sells and assigns to Assignee, its successors, assigns and legal representatives the full and exclusive right, title, and interest to the inventions disclosed in said Properties throughout the world, including the right to file applications and obtain patents, utility models, industrial models, and designs for the inventions in the Assignee's own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of the inventions and all rights to register the inventions in appropriate registries, all foreign rights arising from pre-grant publication of the Properties; and Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee, its successors, assigns and legal representatives.

Assignor further agrees to communicate to Assignee, its successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Properties in all countries.


