- (iii) the right to file applications for, and be granted, patents, supplementary protection certificates, brevets d'invention, utility models, registered designs and other intellectual property and like rights in any country of the world in respect of the invention and improvements, whether under national, regional or international arrangements, in or for any country in the world, in the name of the Assignee its successors and assigns or in the name of the Assignor or in such other name or names as the Assignee its successors and assigns may desire, and the right to sue for

damages and other remedies in respect of any infringement of such rights, and the Assignor acknowledges that if any such applications are filed or rights granted in the name of the Assignor the same shall be held in trust by the Assignor for the Assignee its successors and assigns and shall at the request of Assignee its successors and assigns be transferred from the Assignor to Assignee its successors and assigns for no further consideration; and

(iv) the right to claim priority under any national, regional or international treaty from the Application and from any other application for intellectual property rights in respect of the invention and improvements.

The Assignor hereby authorizes and requests the Commissioner of Patents or other like authority in each respective country to issue said Letters Patents to said Assignee its successors and assigns.


