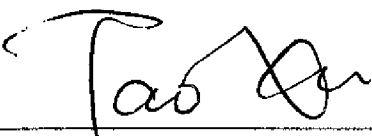
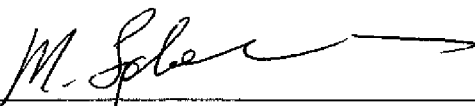
ASSIGNMENT OF PATENT APPLICATION
