ASSIGNMENT

This Assignment is made and entered into by and between CLOCCHIATTI LORIS, residing at Via Divisione Julia, 33 – 33010 Magnano in Riviera, Italy, and MIGALI SIMONE ANTONIO, residing at Via Monte Grappa, 66 – 33100 Udine, Italy, (collectively hereinafter “INVENTORS”), and DANIELI & C. INVENTORS hereby sell, assign, and transfer to ASSIGNEE, its successors and assigns, the entire right, title and interest, so far as concerns the United States and the Territories and Possessions thereof and all foreign countries, in and to the inventions set forth in the application for United States Letters Patent executed by the INVENTORS, said application for United States Letters Patent, any and all other applications for Letters Patent on said inventions in the United States and in countries foreign to the United States, including all divisional, renewal, extension, reexamination, substitute, continuation, continuation-in-part, reissue, and Convention applications based in whole or in part upon said inventions or upon said applications, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent.

2. ASSIGNEE is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of ASSIGNEE or otherwise as ASSIGNEE may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to ASSIGNEE in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTORS, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.






