


e. I acknowledge that this agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.

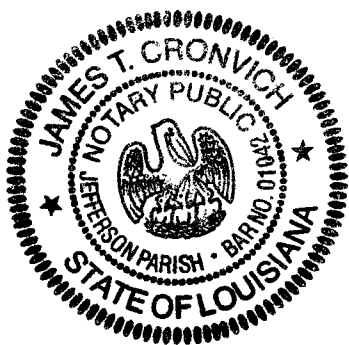


