AND, Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks to record this assignment to Assignee of its entire interest, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent therewith.
