enforcement and defense of Letters Patent for said inventions, without charge to the said Assignors, their successors, legal representatives and assigns, but at the cost and expense of the said Assignee, its successors, legal representatives and assigns.

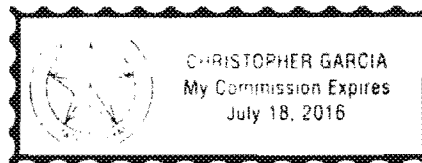
