Assignor agrees to execute any further papers and to do such other acts as may be necessary and proper, or otherwise required by the Intellectual Property Assignment Agreement entered into as of even date herewith by Assignor and Assignee, to vest full title in and to the Patents in Assignee.

If any provision of this Assignment shall be adjudged by any court of competent jurisdiction to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this Assignment shall otherwise remain in full force and effect and enforceable. This Assignment will be deemed to have been made in, and shall be construed pursuant to the laws of the State of Delaware without regard to conflicts of laws provisions thereof.

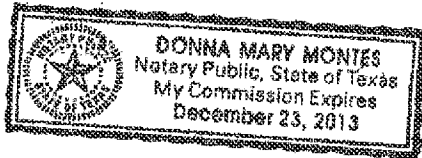
