Assignor hereby requests and the Commissioner of Patents and Trademarks is hereby authorized to issue any United States Patent issuing from the said Patent Applications to both AUDI AG and AUTOMOTIVE SAFETY TECHNOLOGIES GMBH as co-owners to have and to hold to the full end of the term of any issuing patent as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment, transfer and sale had not been made; and

Assignor hereby covenants with Assignee-in-Part, its successors, assigns and legal representatives that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others, and that the full right to convey the same as herein expressed is possessed by Assignor.
