**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN PATENT RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT RIGHTS (this "Termination and Release") dated as of April 9, 2014 from Bank of America, N.A., in its capacity as Administrative Agent and Collateral Agent (the "Agent") for the Secured Parties (as defined in the Credit Agreement), to the entities listed on Schedule B hereto (the "Grantors").

WITNESSETH:

WHEREAS, pursuant to (i) that certain Guarantee and Collateral Agreement, dated as of May 23, 2011, among the Grantors and the Agent (together with all amendments and modifications, if any, from time to time made thereto, the "Security Agreement") and (ii) the several Grant of Security Interest in Patent Rights agreements, each dated as of May 23, 2011, between the Agent and the Grantors (the "IP Security Agreement"), the Grantors granted to the Agent for the benefit of the Agent and the other Secured Parties, a security interest (the "Security Interest") in certain collateral, including the Patent Collateral (as hereinafter defined);

WHEREAS, the IP Security Agreements were recorded in the United States Patent and Trademark Office on (i) June 24, 2011, at Reel 26499 and Frame 0118; (ii) June 24, 2011, at Reel 26498 and Frame 0464; (iii) June 24, 2011, at Reel 26498 and Frame 0401; (iv) June 24, 2011, at Reel 26499 and Frame 0443; and (v) June 24, 2011, at Reel 26499 and Frame 0428;


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Patent Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Patent Collateral, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Patent Collateral," as used herein, shall mean all of the Grantor's right, title and interest in, to and under the Patents listed on Schedule A hereto, including the right to receive all Proceeds therefrom. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release, including the preamble and the recitals, have the meanings provided or provided by reference in the Security Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Patent Collateral, and any right, title or interest of the Agent in such Patent Collateral shall hereby cease and become void.
