Assignor agrees that Assignee may apply for and receive any Letters Patent, utility model, and other similar rights anywhere in the world in its own name, and Assignor further authorizes and requests the US Commissioner of Patents and Trademarks or any other proper officer or agency of any country to record this assignment and issue all resulting Letters Patent, Utility Model Registration, Inventor's Certificate, copyrights, and other similar rights to Assignee; and

Assignor warrants and covenants that at the time of execution of this Assignment Assignor has the full right to convey the entire interest herein assigned and that Assignor has not assigned, transferred, licensed or encumbered Assignor's rights therein, and that Assignor will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with this Assignment; and

Assignor agrees to execute such further documents and take such acts as reasonably required by Assignee or Assignee's successor to secure and enforce Assignee's rights in the invention, the

Application, and any patent, utility model, or other similar rights which may be granted thereon, including but not limited to further assignments.
