I do further agree for myself and for my heirs, executors and administrators, to execute and deliver without further consideration any further applications, assignments and documents, and to perform such other acts as I lawfully may, that may be deemed necessary by the said **PRAIRIE PHARMS, LLC**, its successors, assigns and nominees, fully to secure its interest as aforesaid and to obtain or maintain Letters Patent in any and all countries.

And I do hereby authorize and request the Commissioner of Patents to issue any and all Letters Patent which may be granted upon any of the said applications, to the said **PRAIRIE PHARMS, LLC**, as the assignee of the entire interest therein.
