## ASSIGNMENT

WHEREAS, **Vincent A. Rossi**, a citizen of the United States, residing at 65 Western Industrial Drive, Cranston, RI 02921 and **Stephanie A. And ASSIGNORS further covenant and agree that they will communicate to ASSIGNEE, their successors, assigns or other legal representatives, any facts known to them respecting the Patent Rights, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE, their successors, assigns or other legal representatives to obtain and enforce proper patent protection for said Patent Rights.

And ASSIGNORS hereby covenant that they have full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith.
