This agreement is dated 04/11/2013

Parties

- (1) **Sandro Meneghello e Marco Paolelli** having their address at via Palestrina 22, 20124 Milano, Italy and via Stradella 9a, 20100 Milano, Italy (**Assignors**); and
- (2) **Victoria & Albert Baths Limited** incorporated and registered in England and Wales with company number 05639969 whose registered office is at Vanda House Heath Mill Road, Wombourne, Wolverhampton, Staffordshire, United Kingdom. WV5 8AP (**Assignee**).

Background

(A) The Assignors has been engaged by the Assignee to design a new design of a bath and basin conveniently referred to as the Amiata Bath and Basin (The Design) details of which are appended in Appendix I;

(B) The exploitation of The Design is subject to a separate Licence Agreement (The Licence) signed on the [REDACTED] which specifies a royalty from the Assignee to the Assignor of [REDACTED] of the net turnover;

(C) It is desired to ensure that the ownership of The Design is correctly reflected for the purposes of filing registrations for the protection of The Design; and

(D) It is noted that the Assignors have asserted their moral right to be identified as The Designers and nothing in this Agreement is intended to affect that assertion and it is agreed that the Assignors may continue to use images relating to The Design for marketing purposes, including on their Website, portfolio and presentations.

Assignment

(1) In consideration of the monies paid to The Assignors for the design work (receipt of which the Assignors expressly acknowledges) including that specified in The Licence, the Assignors hereby assign, to the Assignee absolutely with full title guarantee all the right, title and interest in and to the following rights:

(a) all copyright, database rights and rights in the nature of copyright and database rights subsisting in the whole or any part of The Design and in all preliminary drafts or earlier versions of The Design, and

(b) all unregistered Community design rights, and design right and rights in the nature of design right throughout the world, and the right to apply for registered design or similar protection conferred by the law of the UK and all other countries of the world subsisting in the

whole or any part of The Design and in all preliminary drafts or earlier versions of The Design and in the Materials used in the creation of The Design.

in each case for the full term of the same including any renewals, reversions, extensions or revivals, and together with all related rights and powers arising or accrued, including the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of these assigned rights, whether occurring before, on or after the date of this agreement.

(2) The Assignors hereby agree to complete all necessary acts and things as may be reasonably requested by the Assignee to enable the Assignee to be officially recorded as proprietor of the said Intellectual Property Rights.


Governing law





