Acknowledgement of No Patent Rights

This Agreement is entered into this 5 day of June, 2014 by and between Judgment Recovery Assistance, LLC ("JRA") and Sonendo, Inc. ("Sonendo"). JRA and Sonendo may be referred to in this Agreement collectively as "Parties."

WHEREAS, JRA recorded a document with the United States Patent Office on June 22, 2012, attached hereto as Exhibit A ("the Recorded Document");

WHEREAS, the cover page describes the Recorded Document as purportedly conveying rights in, *inter alia*, United States Patent Application No. 11/737,710 and United States Patent Nos. 6,497,572 and 6,224,378 (the "Patent Documents"); and

WHEREAS, JRA and Sonendo wish to clarify title in the Patent Documents and have agreed to work together for this purpose.


NOW, THEREFORE, in consideration of the premises and mutual promises contained in this Agreement, JRA and Sonendo agree as follows:

1. The Recorded Document is an assignment from The Aegis Group to JRA concerning a court judgment and is not an assignment of any rights in the Patent Documents. Additionally, the assigned judgment is not against Sonendo, Inc. (formerly known as Dentatek Corporation).
2. Although the cover page of the Recorded Document lists Rex E. Doherty, Dentajet, Surgijet, Inc., and Lance Doherty as conveying parties, none of these entities or persons is an assigning party in the Recorded Document.
3. JRA has never had and currently does not have any right, title, or interest in or to any of the Patent Documents.
4. Sonendo rightfully owns United States Patent Application No. 11/737,710 and United States Patent Nos. 6,497,572 and 6,224,378. JRA further agrees to execute any documents necessary to assist Sonendo to clear its title in United States Patent Application No. 11/737,710 and United States Patent Nos. 6,497,572 and 6,224,378.
5. Sonendo agrees not to pursue recovery from JRA for the costs or attorney fees that Sonendo has incurred to date to clear any ambiguity in title created by the Recorded Document. Sonendo will be responsible for and will have sole discretion in recording this Agreement against the Patent Documents.

6. This Agreement may be executed in two counterparts and by the Parties hereto in separate counterparts, each of which shall be deemed to be one and the same instrument.



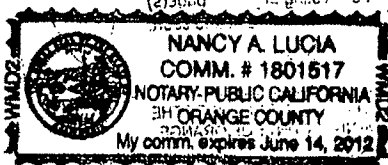
