## PATENT AND COPYRIGHT ASSIGNMENT AGREEMENT

This Agreement is entered into this 17<sup>th</sup> day of October, 2009 by and between Binary Poetry, Inc., a California corporation, having a business address at 590 Olive Avenue, Brea, California 92821 (hereinafter "BINARY"), Timothy Isaac, an individual, having a residence address at 590 Olive Avenue, Brea, California 92821 (hereinafter "MR. ISAAC") and Bitesize Media, Inc., a California corporation, having a business address at 590 Olive Avenue, Brea, California 92821 (hereinafter "BITESIZE").

WHEREAS, BINARY and/or MR. ISAAC have conceived and developed an original software program directed to the subject matter disclosed in U.S. Pat. App. Ser. No. 61/198,043 ('043 Patent Application), filed November 1, 2008 with the United States Patent and Trademark Office;

WHEREAS, BINARY and/or MR. ISAAC own the patent rights regarding the subject matter of the '043 Patent Application;

WHEREAS, BINARY and/or MR. ISAAC own the entire right, title and interest, in, to and under said improvements disclosed in the '043 Patent Application;

WHEREAS, BINARY and MR. ISAAC desire to transfer all right, title and interest in the improvement disclosed in the '043 Patent Application and any software directed to the subject matter of the '043 Patent Application to BITESIZE;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other mutual covenants and conditions stated herein, BINARY, MR. ISAAC and BITESIZE do hereby agree as follows:

1. BINARY and MR. ISAAC hereby assign all right, title and interest, including the copyrights in the software program directed to the subject matter disclosed in the '043 Patent Application and patent rights relating to the subject matter of the '043 Patent Application to BITESIZE and acknowledge BITESIZE as the sole and exclusive owner thereof.

2. BINARY and MR. ISAAC acknowledge that any software development directed to the subject matter of the '043 Patent Application will be considered a "work made for hire" in accordance with the provisions of United States copyright laws,

whereby BITESIZE will be considered the author of the same and own all right, title and interest to the software and the copyrights therein. If for any reason the software is not considered a "work made for hire," BINARY and MR. ISAAC hereby assign all right, title and interest in the software including the copyrights therein to BITESIZE.

3. BINARY and MR. ISAACS by these presents do sell, assign and transfer unto BITESIZE the full and exclusive right to the said improvement disclosed in the '043 Patent Application, and by these presents do hereby sell, assign, transfer and set over, unto BITESIZE, its successors, legal representatives and assigns, BINARY's and MR. ISAACS's entire right, title and interest in, to and under said improvements, and said application and all non-provisional applications, divisions, renewals, continuations, and continuations-in-part thereof, and all United States Letters patent which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, including the full right to claim for any such application the priority benefits of the International Convention for the Protection of Industrial Property and other priority-conferring treaties, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, divisions, continuations, continuations-in-part, renewals and reissues thereof. BINARY and MR. ISAACS hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to BITESIZE, its successors, legal representatives and assigns, in accordance with the terms of this Agreement. BINARY and MR. ISAACS hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Patent to BITESIZE, of the entire right, title, and interest in and to the same, for BITESIZE's sole use and behoof; and for the use and behoof of BITESIZE's legal representatives, to the full end of the term for which said Patent may be granted, as fully and entirely as the same would have been held by BINARY and/or MR. ISAACS had this assignment and sale not been made.

4. BINARY and MR. ISAAC represent and warrant that they have not entered into any contract or made any commitments that will or may impair BITESIZE's

rights hereunder. At any time and from time to time hereafter, BINARY and MR. ISAAC shall upon BITESIZE's reasonable request take any and all steps to execute, acknowledge, and deliver to BITESIZE any and all further instruments and assurances necessary where expedient in order to vest the aforesaid rights and causes of action more effectively to BITESIZE.
