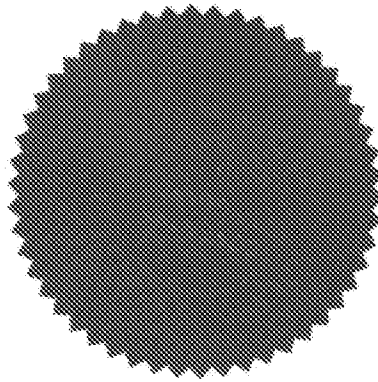
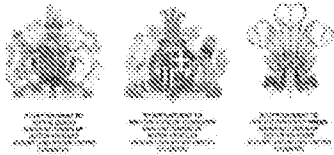

**Consolidation of Jaguar Cars Limited and Land Rover businesses**

This letter is to notify you of changes that have recently taken place as part of the consolidation of the Jaguar Land Rover group as part of our efforts to simplify our group structure.

We confirm that:

- On 28 December 2012 Jaguar Cars Limited (English company, with company number: 1672070), changed its name to Jaguar Land Rover Limited as evidence in the attached certified copy of the change of name certificate issued by the Registrar of Companies;
- On 1 January 2013 Jaguar Land Rover Limited acquired the business of Land Rover, other than its shareholdings in Jaguar Land Rover Automotive Trading (Shanghai) Co. Ltd. Land Rover is an English company, with company number 04019301 and the parent company of Jaguar Land Rover Limited; and
- On 1 April 2013 Jaguar Land Rover Exports Limited (English company, with company number 1672065) transferred its business to its parent company Jaguar Land Rover Limited.

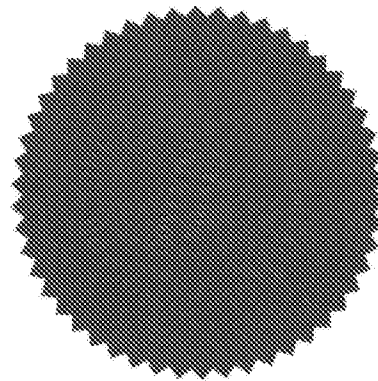
