
WHEREAS, the Agent has agreed to terminate and release its security interest in the Patents as herein provided.



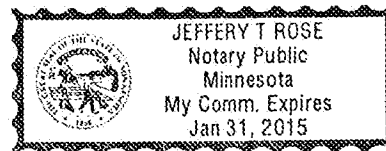
