GENERAL ASSIGNMENT AND ASSUMPTION

Codman covenants and agrees that as of the date set forth above, Codman hereby assumes the obligations and duties of Micrus under the liabilities associated with the Transferred Assets, if any, as required by the terms of the Agreement, and Codman shall be bound by the terms of the governing agreements, commitments, and instruments that it is required to assume by the terms of the Agreement with the same force and effect as if Codman was an original party to such governing agreements, commitments, and instruments.


