ASSIGNMENT

WHEREAS, WE, **James P. Wersching**, a citizen of the United States, residing in Cincinnati, OH, **Gary L. Uthe**, a citizen of the United States, residing in Fort Wright, KY, **Richard W. Block**, a citizen of the United States, residing in Cincinnati, OH, and **Douglas A. ASSIGNORS HEREBY authorize and request the Director of the United States Patent and Trademark Office, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.




