**ASSIGNMENT OF PATENT**

The Assignor hereby assigns, grants and conveys to the Assignee, and its successors and assigns, all right, title and interest in and to the Patent, the Invention, and all divisions, renewals and continuations thereof, and all other Patent of the United States which may be granted thereon and all reissues and extensions thereof; all applications for industrial property protection, including, without limitation, all applications for Patent, utility models, and designs which may hereafter be filed for said Invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said Patent under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; all forms of industrial property protection, including, without limitation, Patent, utility models, inventors' certificates and designs which may be granted for said Invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and all rights to sue at law or in equity for any past, present and future infringement, abuse, misappropriation, violation or other impairment thereof.

2. The Assignor will, upon request of the Assignee, execute any other documents which may be necessary or appropriate to perfect in the Assignee the rights, title and interest herein conveyed in the United States or any other country.

3. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same instrument.
